In 2019, approximately 73,600 hours of service were provided by 1,372 volunteers. Over 600 volunteers were referred to assist local nonprofit agencies.

4b (Code:) (Expenses \$ 45,395 including grants of \$) (Revenue \$) EITC Tax Program - Offering free federal and state income tax preparation to low income families in the Allen County and northeast Indiana communities. For 2019, our 41 IRS Certified Tax Volunteers assisted 2,076 taxpayers in five language groups and returned approximately \$2.397 million dollars to Allen County and northeast Indiana families.

4c (Code:) (Expenses \$ 11,278 including grants of \$) (Revenue \$) Second Chance Initiative - Provides legal assistance to low income individuals in the areas of expungement of criminal records and reinstatement of driving privileges, both barriers to employment and financial stability. The program helps reintegrate people with criminal offenses and suspended driving licenses into our communities where they can live, learn, work and thrive. In 2019, a total of 634 individuals received education or one on one legal assistance in filing for expungements or reinstatement of their driving privileges.
